## Discipline objectives (course and practical works)

The course is aimed predominantly following objectives:

- Knowledge and application of specific notions in the field of food quality and authenticity, at the level of the three fundamental links of the agri-food chain producers, processors, and consumers:
- Knowledge of the principles of adoption of consumer protection legislation, concerning food authentication and detection of food fraud the European legislation and national legislation;
- Knowledge of the main types of foodstuffs fraud;
- Knowledge of the institutions and/or structures with attributions in the elaboration of the acquis communautaire regarding the authentication of food and the detection of food fraud;
- Knowledge of the European and national institutions and/or structures with responsibilities in verifying the application of European and national legislation on food authenticity and the detection of food fraud.

Within the practical applications (practical works), the following objectives are predominantly pursued:

- Knowledge of the principles and methods underlying the authentication of food products and the detection of the main types of fraud;
- Knowledge and presentation of the possibilities of counterfeiting the main food groups and especially of the modern possibilities of detecting fraud;
- Knowledge of the main means and techniques for detecting different forms of fraud applicable to food, from classic to modern;
- Knowledge of the main food groups subject to authentication in the European Union and in Romania; Knowledge of the main food groups subject to fraud in the European Union and in Romania;
- Participation in scientific and professional development projects, compatible with the requirements of integration into the national and European labor market.
