Accommodation option	Single room with a communal kitchen and shared bathroom and toilet facilities or double room with a communal kitchen and shared
ορασι	bathroom and toilet facilities.
Separation of the sexes	There are mixed residential communities (i.e. men and women share the communal areas).

Start of rental period	Accommodation can be rented from the beginning or the middle of a month (1st or 16th of the month).

Cancelling the	If you apply in time, a room will be reserved for you. A written room reservation will be emailed to you. If you then do not come to

cancellation fees	do not cancel the reservation or miss the deadline for cancellation, you will be required to pay one month's rent.
Extension of rental	The rental agreement may only be extended if the exchange / programme is extended at the same time. Applications for extension of
agreement	the rental agreement must be submitted to the Student Accommodation Service at least 2 months before the expiry date of the
	agreement . Please submit an informal, signed extension application and enclose a certificate of programme extension from the
	International Office. The Student Accommodation Service will examine the possibility of extending your rental agreement and inform you
	how to proceed. An extension cannot be guaranteed if the application is submitted too late.

	The website also contains a photo gallery for each hall of residence. Most of the rooms have a sink, a bed, a table, a chair, a wardrobe and bookshelves. Showers, toilets and the kitchen are shared with other students. Bedding and bed linen are provided; you need to bring your own towels and crockery. The residence halls all have washing machines for your use. Please note: Room allocation depends on availability and is decided solely by the Student Accommodation Service.

Moving in / moving out	You cannot move in or out at the weekend or on public holidays. Please bear this in mind when planning your arrival and departure. For Giessen and Friedberg, keys may be collected from, and rental agreements signed at, our office at Otto-Behaghel-Strasse 23 during our opening hours: Monday – Thursday: 09.00 – 15.00; Friday: 09.00 – 14.30. See information in your room reservation. In Fulda, keys are collected from the "KeyBox" of the Student Accommodation Service in the hall of residence at Heinrich-von-Bibra-Platz 3, 36037 Fulda, or from the caretaker, Monday – Friday: 08.00 – 14.00 (Tel: 0160 7274016; 0151 62654341). You will be sent information about moving out and releasing the room by post in the month in which you intend to move out.
Terms of rental agreement	You can find an English version of the important points of rental agreement on our homepage at the following link: http://www.studentenwerk-giessen.de/docs/Wohnen/Housing Contract Part 2.pdf Please read it carefully in advance, because you will be asked to sign it upon your arrival.
Relocation	It is generally not possible to relocate within the housing complex or to another hall of residence.
Termination	The rules of the rental agreement stipulate that the statutory period of notice when terminating the rental agreement is 3 months. In exceptional cases – for example, if evidence can be provided that the exchange programme has been cancelled – this period may be reduced. Please note that the rent varies according to the length of your stay.
Deposit refund	In accordance with the rules of the rental agreement, your deposit will be transferred to the bank account that you have indicated 8 weeks after the end of the agreement. Transfer fees must be borne by the tenant. Payments cannot be made in cash. You will be given further information with the documents on moving out in the month in which you intend to move out.
